### Protecting and Promoting our Tongan Traditional Knowledge systems

**Canoe Parade in Honour of** HM King Tupou VI's 61st Birthday



n Tuesday 7th July, 25 canoes from the Canoes of Polynesia Phase 2 project were put to water on the slipper beside the Touliki Naval Base, loaded with excited paddlers who paddled up to form a guard of honor outside the entrance from the naval base, and cheered for His Majesty as he departed on the naval boat VOEA Ngahau Koula on a Royal visit to 'Eua. Also present was HRH Princess Salote Mafile'o Pilolevu Tuita. A specially made popao by Tongan master carver Mr. Tu'i'one Pulotu was gifted at sea to His Majesty who named it Tu'imoana

The Ministry of Tourism is pleased to acknowledge Mr. Pulotu's efforts to contribute to our Traditional Knowledge systems through his customary carving methods and techniques. As previously

reported, the Ministry supports and is in partnership with Mr. Pulotu and associates in spearheading this initiative. It involves mass production of canoes mainly from red cedar. While this project is in progress, young interested future carvers are being trained on the job in canoe-making and students are encouraged to visit, observe and ask questions to Mr. Pulotu on site. It is anticipated that once all the canoes are made, they will be made available for public use while some will be left for the Ministry to manage, creating both tourist and educational water activities in future.

Mr. Pulotu has been instrumental in supporting the Culture Division with their plans to re-open the Tonga National Museum by donating some of his carvings to be exhibited. The Ministry of Tourism would like to thank Pulotu for sharing his work and talent, we are committed to the safe-keeping and protection of our traditional knowledge be passed on to our future to generations.

he opening session for the



welcoming and outlining the aims and objectives of the program to the participants, parents and friends who were present at the occasion, at the St. Andrew High School Hall. This program targets transmission and revival of traditional Tongan dances to young people. Each course runs for 6 consecutive weeks; with 2 or 3 classes each week starting at 4-5:30pm on Tuesdays – Thursdays. A total of 72 participants registered for this dance cohort, which consists of 65 girls and 7 boys respectively. The age range of those participating is from 3 - 22. They will later be divided into smaller groups for ease of teaching. The focus on this first week of classes, is on basic hand, feet and body movements (ngaahi vaa'i haka tefito), before they get to learn individual dances to select songs in the following weeks. A dance recital night for this dance cohort is scheduled for September 23<sup>rd</sup>, 2020.

The Ministry is appreciative of the continuous support and interests from the public of its initiatives, and looks forward to successful collaborations with parents and guardians in running this dance program for our children, the future of our nation.

### In-country Stakeholders Consultation on the Drivers of Change for the Blue Pacific Continent 2050 Strategy



the 13th August 2020, the Prime Minister of Tonga, Hon Rev Dr Tu'i'onetoa Pohiva opened two-day а Stakeholders In-country Consultation on the Drivers of Change for the

Blue Pacific Continent 2050 Strategy this morning at Fa'onelua Convention Centre.

Hosted by the Prime Minister's Office, the event brought together members from line ministries, civil society organizations, private sector businesses, community leaders and academia to deliberate on key trends and issues that may drive change for the development of the Regional 2050 Strategy.

Hon. Rev Dr Pohiva Tu'i'onetoa said,

"The world has come to a total lockdown from the global pandemic of COVID-19."

"Three decades ago, such a reality was unheard and we consider this to only happen in the movies. But today, our isolated region is not spared the impacts of Climate Change, pandemics, cyber terrorism these are real issues and these are the trends of our time."

"As a leader, I personally feel that political will is not enough, every commitment rendered at every level is key to the achievement of this

vision."

The working vision for 2050 was endorsed by the Forum Officials Committee (FOC) Sub-Committee are as follows:

In 2050, the Blue Pacific Continent is a region of peace; harmony; security, social inclusion; and increased prosperity so that all Pacific people are leading free, healthy and productive lives.

Our Blue Pacific identity reinforces the potential of our shared stewardship of the Pacific Ocean and reaffirms the connections of Pacific peoples with their natural resources, environment, cultures and livelihoods.

We understand that this vision can only be achieved through the regions collective action.

He said that every forum member must feel responsible to be part of this process and action plan.

### **Ministry of Trade & Economic Development Highlights**

### **Tonga's Policy Framework and National e-Commerce Readiness Assessment launched**



#### Theme: 'Weaving a Sustainable Trade for Tonga'

On the 12th August 2020, Prime Minister national e-Commerce readiness assessment Hon Rev Dr Pohiva Tu'i'onetoa launched and the trade policy framework." He said the Tonga's Trade Policy Framework (TTPF) and framework was developed with the hope of the National e-Commerce Readiness Assessment under the theme 'Weaving a Sustainable Trade for Tonga' at Ancient Tonga, Fangaloto.

The development of TTPF started in early 2016 through technical assistance from the Pacific Islands and support from the i. International Trade Centre and the Commonwealth Secretariat through the ii. Hubs and Spokes Programme. A series of consultations with government and stakeholders non-government were convened during the development of TTPF. The work to formulate the National e-Commerce Readiness started last year led by the Ministry of Trade and Economic Development in collaboration with the Ministry of MEIDECC and was supported by Australian Government. the Hon Tu'i'onetoa said the "theme provides a forward looking approach to consider trade opportunities in the long run. This theme highlights the interrelationship between the

providing a pathway to address challenges and reposition Tonga's social economic development with Tonga's Strategio Development Framework II.

The framework is grouped into four pillars which include –

- Industrial investment and development
- Export development and trade facilitation
- iii. Development of trade supporting institutional services; and
- iv. Inclusivity and citizens economic empowerment.

"The key objective of this policy framework has been mainstreamed into our Strategic Development Framework 2015 - 2025. This policy is recommended to address the barriers of trade and on trade negotiations suitable to guide the public policy for the next eight years. It also acknowledges the role our development partners in supporting to expand our trade capacity. It

will be useful to attract and mobilise aid for trade and other assistances for capacity building and investment in Tonga. It provides a useful model for Tonga to measure its readiness for e-Commerce along policy areas including e-Commerce trade logistics, trade facilitation, ICT infrastructure, legal and regulatory framework and skills development."

Minister for Trade Economic and Development Hon Samiu Vaipulu said, "The final trade policy framework reflects the views of all stakeholders consulted." According to Hon Vaipulu the National e-Commerce Readiness "provides а thorough assessment of Tonga's e-Commerce environment whereby identifying the key challenges issues during and the consultations and establishes priorities for the Government of Tonga to consider and proposes avenues to mobilise funding for e-Commerce activities from donor partners."

The event was attended by government officials, members of the diplomatic corps and many other guests.

# **MEIDECC Highlights**



#### National Ozone layer Protection Training

**O** n the 14th August 2020, the national ozone layer protection unit from the department of climate change – ministry of MEIDECC, collaboratively conducted a two-day (13 – 14/08/2020) training with the Ministry of Revenue and Customs, targeting custom officers and brokers newly recruited to the field of border security at the Fe'ao Mo e Ngalu conference room, Nuku'alofa.

The aim of the training was to share with the target audience the science of the ozone layer, Montreal protocol, Ozone Layer Protection Act 2010 and all the knowledge that is fully required by any custom officer to effectively implement their duties in securing the border such as risk profiling, documentation and inspection techniques.

Mr. 'Aloisio Fifita, a member of the ozone team from the department of emphasized climate change the importance of safeguarding the ozone from severe deterioration and keeping the balance between its rate of natural production and innate depletion, by avoiding the consumption and illegal trade of controlled substances listed in the Ozone Layer Protection Act 2010 & 2014. "Enforcement of the Ozone Protection Act highly contributes to the safeguarding of the ozone layer as well as the wellbeing of the customer and depleting handlers of ozone substances," stated Mr. Fifita at the conclusion of his presentation.

Furthermore, Mr. Sau Niulala from customs and revenue explicated to the participants the significance of controlling the border and its association with the safeguarding of the ozone layer. He highlighted during his presentation that the smuggling of ozone depleting substances has entered our shores and it is the utmost responsibility of any custom officer on the field to combat these illegal actions by applying the right and proper procedures discussed and delivered during this training. He concluded by urging his officers to be vigilant whilst on duty for there has been several foreign businesses in the past few years attempting to import illegal refrigerants in a very professional and disguised method.

The training was attended by more than twenty officers from different divisions of the customs and revenue ministry. Comprehensive discussions on ozone related matters and custom duties were the essence of this training. This training is carried out on a yearly basis and funded by the United Nations Environmental Programs.

### Improving communities resilience to natural disasters through DRR awareness

he District and Town Officers from Tongatapu 10 and Tongatapu 9, participated in a Disaster Risk Reduction (DRR) awareness



program led by the National Emergency Management Office

(NEMO) at Tatakamotonga's community hall on 12th August, 2020.

The outreach program is part of NEMO's annual awareness program dubbed as "*Ta e Lango Kei Mama'o*" which aims to improve communities' resilience to natural disasters and climate change.

The program is also anticipated to help communities facilitate the formulation of their respective Disaster Risk Management (DRM) committees and plans, strengthen existing DRM committees and assist NEMO in achieving one of Sendai Framework's target to reduce loss of lives, destruction of properties and number of people affected by disasters.

Director of NEMO Mr Mafua Maka said, "This Disaster Risk Reduction Awareness Program for communities is part of our preparation for the Tropical Cyclone Season 2020-2021 focusing on building the existing capacity of the district and town officers with their Village Emergency Management Committees and Village Emergency Management Plan."

Today was the beginning of the program and it will continue to cover all of Tonga until November this year.

### APPOINTMENT OF MRS.'ELISAPETI LANGI AS AN ACTING JUDGE OF THE SUPREME COURT



Over the last 12 to 18 months, a surge in class A drug-related offences has caused significantly increased caseloads in the Supreme Court criminal division. Without additional judicial resources, many cases would be at risk of inordinate delays which in turn poses a threat to the due and

To assist in meeting this challenge, on 30 July 2020, His Majesty, King Tupou VI, in Council, approved the appointment of Mrs. 'Elisapeti Langi as an Acting Judge of the Supreme Court pursuant to clause 88(2) of the Constitution of Tonga.

After inviting expressions of interest from the entire Tongan legal profession, Mrs Langi was chosen from the ranks of the Magistracy where she has been serving for the past approximately three years as a Senior Magistrate. In July 2019, she was invested by Chief Justice Paulsen with enhanced jurisdiction. Prior to joining the Magistracy, Mrs Langi served as an Assistant Senior Crown Prosecutor for 10 years. Her career at the Bar has included high profile and important cases such as successfully prosecuting the first case under the Computer Crimes Act and counsel assisting the Royal Commission of Inquiry into the sinking of the MV Princess Ashika. Mrs Langi holds a Bachelor of Laws,

a Master's in Criminology and other legal academic qualifications. She has contributed to the advancement of the profession and is highly regarded within the legal community, both in Tonga and overseas. In 2014, she was awarded the prestigious Australian Leadership Award. Mrs Langi's appointment is initially for a period of four months with effect from September 2020.

# Consultation to Review the Concept Design of the New Courts Complex



A consultation to review the New Law Courts Complex Concept Design was conducted on the 21<sup>st</sup> of August at Fe'aomoengalu Hall. There were thirty-seven (37) participants all together including the members from the Judiciary, Government line Ministries and departments, the NGOs and few of the Ministry's Head of Divisions. The presentation was made by Mrs. Catherine Whitten, the architect responsible for the Concept Design for this project.

Whitten Mrs. impressed the participants with the modern design of the traditional FALE. She emphasized the importance of designing a building especially a court house with consideration and being mindful of the needs for inclusiveness. The New Law Court House is designed for men, women, children, youth, disabled persons, courts staff and officers of the courts

or in her own terms, Mrs. Whitten referred to everyone.

In the Concept Design, Mrs. Whitten pointed out the space designed for vulnerable members of the public such as domestic violence survivors and victims, the designated areas for the Police, Prisoners, Guards and facilities safeguard all Court users. This modern design interwoven with traditional Tongan themes/iconic representation is designed with the renewable energy in mind and excide aesthetic qualities that would be unique in the region.

There was an open discussion after the presentation and most of the comments complimented the work done and in appreciation of progress towards finally having a proper Law Courts for the Kingdom. The substantial interest and hope is that the project will see fruition in the next 3 years or so.



# **Ministry of Justice Highlights**

#### **Capacity-Building Initiative**

The Hon. Deputy Prime Minister and Minister of Justice and Prisons, Hon. Sione Vuna Fa'otusia kindly endorsed the Ministry of Justice's "Capacity-Building Initiative" proposal initiated by Chief Executive Officer for Justice, Mrs. Temaleti M. A. Pahulu. The proposal allows for the Ministry to assist its staff members with their respective capacity building initiatives particularly in furthering their academic endeavors. This proposal came just in time when The University of the South Pacific (USP) added a new study programme, namely the Certificate and Diploma of Justice for the disciplines enlisted under the Faculty of Arts, Law and Education (FALE) in 2019. The CEO and relevant officers negotiated the "Capacity-Building Initiative" with the Ministry of Finance which was eventually approved in principle and deemed as a scholarship funded by the Ministry of Justice. This scholarship opportunity was intended for all permanent staff members of the Ministry who were interested in pursuing a career in the discipline of Law. The scholarship was announced and four (4) staff members were selected on merit based criterion that have served the Ministry of Justice for several years and were willing to continue on serving, upon the successful completion of the intended course of study. The scholarship recipients are also given other benefits from the Ministry including internet access and flexible working hours

#### Special Amnesty Program for School Children

The Office of the Registrar General conducted a Special Amnesty Program for School Children commencing on the 3<sup>rd</sup> to the 31<sup>st</sup> of August, 2020. This resulted from concern raised by Ministry of Education. It is the third such exercise designed to capture unregistered individuals. The purpose of the Amnesty Program was to waive registration fees for children who have yet to be registered in Tonga's Civil Registry. This opportunity was specifically to children from Kindergarten up to Tertiary School students who have not registered their births at the Tonga's Civil Registry.

# **Oversight Highlights**

### **Reconciling PSC Office's HR Data**

٠

There has been a need for accurate HR data that will ultimately result in informed decision making concerning Human Resource in the Tonga Public Service.

The PSC Office has initiated work since March 2020 in reconciling its own Human Resource data. This initiative is a critical part of the Office's work in ensuring that it retains updated Human Resource Data but most importantly, that these data are accurate. The development of this initiative is driven by the need for quality HR data, subsequently followed by sound analysis and effective analytics that meet the needs of various Decision Making positions, for sound decision making.

The work being undertaken is expected to feed into a HR Registry of the Office of the PSC. This work includes:

Reconciling and resolving of civil servant lists retained separately by Workforce Development Division, and Oversight Division of the PSC Office (i.e. lists that were reconciled with Finance's payroll data and the Human Resource data kept by the twenty (20) line ministries that are under Schedule I of the Public Service Act);





 Updating and merging PSC Office Workforce Development, and Oversight civil servants lists into a single list;





Matching of resolved civil servant lists with organizational structures submitted from Schedule I of the Public Service Act's line ministries to ensure that all civil servants data are accounted for and maintained;



The major portion of work that is yet to be completed is on the Human Resource data of Ministry of Education & Training's civil servants list.

A way forward on this initiative is the alignment of existing HR data sets with those required by the Public Service instructions which will require input of data for all civil servants.

PSC Office has continued to plan progressing this work further by coordinating data needs and readily available and requested data sets within the PSC Office so that they are consolidated and coordinated into a single HR Registry that will provide customized reports to meet HR data needs.

It is anticipated that this work will not only improve coordination of existing Human Resource work efforts within the PSC but will also mean greater work collaboration among the Divisions of the PSC Office and with line ministries. In the longer term, this may mean a more improved data analysis for decision making.

The Oversight team would also like to acknowledge the coordinated efforts of all the PSC Office Divisions: file team and ICT of Corporate for attending to files; Performance Development for reporting lines data; Remuneration team for confirmation of bands; Human Resource team for following up additional HR data from line ministries; **The efforts of the responsible staff from line ministries are greatly appreciated.**
